Measure 1: Support Public Safety and Public Transportation

Do you believe in providing reliable public transportation for all residents, regardless of their income?

A new citizen-driven initiative is on the horizon, proposing a half-cent sales tax that will help fund public safety and public transportation needs."

The initiative was finally achieved and realized into Measure #1, and will be listed on the November general election ballot. The video goes on to explain:

"What does this mean for our vibrant community? Three-tenths of a cent of this measure will be dedicated to public safety.

These funds will be used for the construction of police and fire stations, acquiring essential emergency vehicles, and covering the cost to continue utilizing the Burleigh/Morton Detention Center.

Investing in our facilities and fleet ensures that our first responders are equipped to maintain the safety of our expanding community.

Additionally, two-tenths of cent will be allocated to public transportation needs.

This guarantees that everyone has the opportunity to live independently in their homes and thrive in our community.

In recent years, Bismarck has undergone significant economic development.

Every citizen, including your family and friends, deserves the opportunity to enjoy these improvements.

By allocating resources to public transportation, we



can support the elderly, disabled, and financially challenged.

Polling site assessments important

Everybody has the right to vote, in a safe, confidential and accessible space.

DCIL, Independence Inc.- Minot, Options Resource Center- E. Grand Forks, and Freedom Resource Center-Fargo collaborated with Protection and Advocacy to do select assessments of polling sites per the Help America Vote Act (HAVA).

Areas looked at were parking, exterior route to the entrance, entrance, interior route to the polling site, and voting space.

Barriers like gaps in the sidewalks, ramps with a high slope, 1-inch lips into the doorway, stairs into the main

entrance, no power doors, and space to move around in all directions are just to name a few. Shockingly, accessible parking was the biggest barrier at these polling locations.

If corrections are needed, temporary measures need to be in place on the day of the election so everyone has easy access for voting.

McCallie remained diligent to serve her consumer

DCIL employee McCallie Willows has an individual she is working with through the NDTDPP program who needs some pretty extensive modifications to his home. He needs a ramp built and a bathroom modification so that he can access his shower.

McCallie got a quote for modifications from a contractor that was near \$32,000 and of course could not be approved by TDPP because of the amount. It was taken all the way to the ND Aging Services Director for approval, and it was denied due to the amount.

McCallie was not going to give up as she knows how important it is for

this consumer to remain in his own home and if the modifications were not completed, he would need to consider moving. McCallie worked for weeks with the consumer to apply for other grant programs to help with the cost of the modifications and also worked with the contractor to see if they could reduce the cost as well. She was able to get another grant approved for \$5000 and the contractor was willing to come down to around \$12,000 for both the deck and bathroom remodel. Even by reducing some of the items included in the remodel, the construction will still make the bathroom accessible.

McCallie submitted her funding re-

quest again to the state and it was again presented to the ND Aging Services Director and this time it was approved!! The consumer will get the modifications done that he needs to help him remain in his home for years to come!!

McCallie added, "I'm still in shock that I was finally able to get this approved. The consumer was so happy that he teared up because of how grateful he is for everything that has been done for him. I managed to get another 1k taken off the bathroom estimate this morning so now the final total is even lower! This consumer now gets a true chance at staying in his home for the rest of his life because of TDSPP."

DCIL saw so many success stories this month that we weren't able to fit all the details!

- Compliment received for one of our IL Specialists, "I haven't even locked my doors since you saved my life and got me out of the bad place I was living. You changed my life!"
- Stephanie Scott and Kianna Roecker worked together by using their previous experiences with Medicaid applications and applying to other resources to ease a consumer's anxiety about filling out forms. Good job Stephanie Scott & Kianna Roecker!
- Kathy Temechack had a consumer in the office needing help with a social security issue. The consumer's worker stated how much this consumer trusted and appreciated all the work Kathy has done for him, as he doesn't trust anyone but her anymore. Kathy truly cares about her consumers and their well being, way to be there for them, Kathy!
